 - b) the lessor carries out his or her obligations;
- 2) refuse to remit the deposit to the lessor and allow the lessee to continue depositing the rent until such time as:
 - a) the person to who the lessee must pay the rent is identified or found;
 - b) the lessor has carried out his or her obligations;
- 3) authorize the remittance of the deposit to the lessee to perform the obligations of the lessor.

A decision authorizing the withdrawal of the rent is followed by an application for withdrawal, accompanied by a certificate of non-appeal, where applicable.

See the office of the Court of Québec of the district where the dwelling is located to obtain a certificate.
